7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Executive to hire**
9 **externally one person into a full-time, bargaining, classified, Wastewater Treatment Plant**
10 **("WWTP") Operator 1 position, at an hourly rate not to exceed \$19.77, for the Executive's**
11 **Department of Environmental Services and declaring an emergency.**

13 WHEREAS, this Council previously adopted Ordinance Nos. 2009-110 and 2001-204,
14 which enacted and extended, respectively, Section 169.04(j) of the Codified Ordinances of the
15 County of Summit, entitled "Temporary Hiring Freeze," to control and reduce the County's
16 budget deficit; and

17
18 WHEREAS, Section 169.04(j) of the Codified Ordinances of the County of Summit
19 provides that if a County office is able to demonstrate that the filling of an existing position by
20 hiring an employee is necessary for the effective and continued operation of the office, Council
21 may adopt a resolution authorizing the office to hire said employees; and

23 WHEREAS, the Executive states that a position of WWTP Operator 1 has been vacant,
24 and that the position has been posted internally and applications were received and reviewed, and

25
26 WHEREAS, no internal applicant met the minimum qualification of Ohio Environmental
27 Protection Agency's ("OEPA's") Operator Certification program, which the WWTP Operator 1
28 position requires; and

30 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
31 is necessary and in the best interest of the County of Summit to authorize the County Executive
32 to hire one external person into a full-time, bargaining, classified, WWTP Operator 1 position at
33 an hourly rate not to exceed \$19.77;

35 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
36 State of Ohio, that:

40 County Council hereby determines that the County Executive's Department of
41 Environmental Services has demonstrated that it is necessary for the effective and continued
42 operation of the office to authorize the County Executive, pursuant to Section 169.04(j) of the
43 Codified Ordinances of the County of Summit, to hire one external person into a full-time,
44 bargaining, classified, Wastewater Treatment Plant ("WWTP") Operator 1 position at an hourly
45 rate not to exceed \$19.77.

49 This Resolution is hereby declared an emergency in the interest of the health, safety and
50 welfare of the citizens of the County of Summit and for the further reason to immediately
51 authorize the County Executive to hire said person in order to continue to effectively operate and
52 maintain the County's waste water treatment plants.
