7 **A Resolution appropriating additional grant funds, in the amount of \$232,908.00, with no**
8 **local cash match requirement, provided by the State of Ohio Department of Rehabilitation**
9 **and Correction (“ODRC”) through the Community Corrections Act (“CCA”) 407 Grant**
10 **for State Fiscal Year 2012, for a Reentry Court as a part of the community corrections**
11 **program to be operated by Oriana House, Inc. and the Adult Probation Department, for**
12 **the period of July 1, 2011 through June 30, 2012, for Executive’s Department of Law,**
13 **Division of Public Safety-Justice Affairs, and declaring an emergency.**

14
15 WHEREAS, ODRC through the CCA renewed the award to the County of Summit of a
16 407 Grant for State Fiscal Year 2012, in the amount of \$1,006,199.00, with no local cash match
17 requirement, for a community corrections program to be operated by the County Adult Probation
18 Department and Oriana House, Inc., for the period of July 1, 2011 through June 30, 2012, and

20 WHEREAS, this Council previously adopted Resolution No. 2011-174, which authorized
21 the County Executive to execute documents necessary to accept the aforementioned grant award
22 and appropriated grant funds; and

24 WHEREAS, the original grant application submitted by the County included additional
25 grant funds, in the amount of \$232,908.00, for a Reentry Court, for a grant total of
26 \$1,239,107.00, with no local cash match requirement, but budget cuts at the State level made it
27 appear that the \$232,908.00 would not be included in the 407 Grant for Fiscal Year 2012; and

29 WHEREAS, the ODRC subsequently included the additional \$232,908.00 for a Reentry
30 Court in the 407 grant award; and

32 WHEREAS, this Council adopted Resolution No. 2011-412, which authorized the
33 Executive to execute a contract with Oriana House, Inc., and the County of Summit Court of
34 Common Pleas, on behalf of the Adult Probation Department, for the operation of a community
35 corrections program for State Fiscal Year 2012, the period July 1, 2011 through June 30, 2012, in
36 the amount of \$1,239,107.00, which is funded by the 407 grant award; and

38 WHEREAS, it is necessary to appropriate the additional 407 grant funds; and

40 WHEREAS, this Council has determined by reviewing all pertinent information that it is
41 necessary and in the best interest of the County of Summit to appropriate the additional
42 \$232,908.00 in funds from the 407 Grant for Fiscal Year 2012 for the aforementioned reasons;

44 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
