WHEREAS, the County of Summit Juvenile Court has been awarded a third BHJJ grant, from the Ohio Department of Mental Health, through the County of Summit Alcohol, Drug Addiction & Mental Health Services Board, for the funding of a local collaborative, in the amount of \$312,621.00, with no local cash match requirement; and

WHEREAS, this funding is to continue the support of the Integrated Co-occurring Treatment and Trauma Focused Cognitive Behavioral Therapy, in addressing those issues for both the serious juvenile offender youth and their families, with the ultimate goal to positively affect behavior, improve coping skills, provide safe and healthy alternatives, and prepare these youth and families to function positively and productively in the home and community; and
