7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a renewal of the County of Summit Juvenile Court's Workforce Investment Act**
9 **("WIA") youth services contract for State Fiscal Year 2012 ("SFY 2012"), in the amount of**
10 **\$93,750.00, federal funding from the County of Summit Department of Job and Family**
11 **Services ("SCDJFS"), with no local cash match requirement, with a nine-month**
12 **performance period of 10/1/11 through 6/30/12, and appropriating these funds for program**
13 **expenditures, for the period 10/1/11 through 12/31/11, for the County of Summit Juvenile**
14 **Court, and declaring an emergency.**

15
16 WHEREAS, SCDJFS has awarded the amount of \$93,750.00 in a renewal of a SFY 2012
17 WIA grant, originally awarded in July of 2010, to the County of Summit Juvenile Court, for the
18 costs of staffing and contract services; and

20 WHEREAS, this grant supports a case manager working with parole officers for the
21 youths committed to lengthy stays, to prepare them for their release, and for their transition after
22 release, including education and training, job readiness and placement, with follow-up services;

25 WHEREAS, this Council finds and determines by reviewing all pertinent information
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
27 execute any documents necessary to accept the award of the aforementioned grant from the
28 SCDJFS, and to appropriate these grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The County Executive is hereby authorized to execute any documents necessary to accept
36 renewal of the County of Summit Juvenile Court's Workforce Investment Act ("WIA") award,
37 for State Fiscal Year 2012 ("SFY 2012") federal funds, with no local cash match requirement,
38 from County of Summit Department of Job and Family Services, for the period 10/1/11 through
39 6/30/12, in the amount of \$93,750.00.
