A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled "Temporary Hiring Freeze," to authorize the County Prosecutor to hire one external person into a part-time, non-bargaining, classified Student Helper position, to work in the Victim Services unit of the Juvenile Division of the Prosecutor's Office, at a rate not to exceed \$10.13 per hour, for an estimated cost for the part-time position of \$12,043.00 annually; for the Prosecutor, and declaring an emergency.

WHEREAS, this Council previously adopted Ordinance No. 2009-110, which enacted Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled "Temporary Hiring Freeze," to control and reduce the County's budget deficit, and Ordinance No. 2011-204, which reinstituted the hiring freeze through December 31, 2012; and

WHEREAS, Section 169.04(j) of the Codified Ordinances of the County of Summit provides that if a County office is able to demonstrate that the filling of an existing position by hiring an employee is necessary for the effective and continued operation of the office, Council may adopt a Resolution authorizing the office to hire said employees; and

WHEREAS, due to separation through resignation, it is necessary for the continued and effective operation of the Prosecutor's Office to be permitted to hire and fill a part-time Student Helper position, which is an entry-level position within the Prosecutor's Office, at a rate not to exceed \$10.13 per hour, for an estimated cost for the part-time position of \$12,043.00 annually; and

WHEREAS, this Council has determined, by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the County Prosecutor to hire an external person into a part-time, non-bargaining, classified Student Helper position.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

County Council hereby determines that the County Prosecutor has demonstrated that it is necessary for the effective and continued operation of her office to authorize the County Prosecutor, pursuant to Section 169.04(j) of the Codified Ordinances of the County of Summit, to hire an external person into a part-time, non-bargaining, classified Student Helper position, at a rate not to exceed \$10.13 per hour, for an estimated cost for the part-time position of \$12,043.00 annually.
