7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award of a High Visibility Enforcement Overtime ("HVEO") grant, from the**  
9 **Ohio Department of Public Safety ("ODPS"), in the amount of \$76,035.00, with no local**  
10 **cash match requirement, for the period 10/1/11 through 9/30/12, and appropriating the**  
11 **grant funds, for the period 10/1/11 through 12/31/11, for the Sheriff, and declaring an**  
12 **emergency.**

14 WHEREAS, County of Summit Sheriff's Office has been awarded \$76,035.00, with no  
15 local cash match requirement, from ODPS, through their Office of Criminal Justice Services  
16 ("OCJS"), in order to operate an HVEO program in the County of Summit, for the period  
17 10/1/11 through 9/30/12; and

19 WHEREAS, the HVEO grant has provided funding for the past 12 years to the Sheriff's  
20 Office for work overtime, in order to conduct high visibility enforcement, public awareness, and  
21 education in the County of Summit; and

23 WHEREAS, it is necessary to appropriate grant funds for the period 10/1/11 through  
24 12/31/11; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that  
27 authorizing the County Executive to execute any documents necessary to accept the  
28 aforementioned grant, and the appropriations of the aforementioned grant funds, is necessary and  
29 in the best interest of the County of Summit;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

36 The County Executive is hereby authorized to execute any documents necessary to accept  
37 a grant award from the Ohio Department of Public Safety for a High Visibility Enforcement  
38 Overtime ("HVEO") grant, in the amount of \$76,035.00, with no local cash match requirement,  
39 for the period 10/1/11 through 9/30/12.

19 effect and be in force at the earliest time provided by law.



27 121.22 of the Ohio Revised Code.


