WHEREAS, the Ohio Department of Public Safety, through the Office of Criminal Justice Services, has awarded the County of Summit Sheriff federal funding for a countywide OVI Task Force program for federal fiscal year 2012; and

WHEREAS, it is necessary and in the best interest of the County of Summit to appropriate all grant funds for the period 10/1/11 through 12/31/11; and

WHEREAS, the Sheriff has been awarded \$198,449.88, with no local cash match requirement, for the countywide OVI Task Force program in order to conduct high visibility enforcement, public awareness, and education for alcohol-related crashes and traffic-related fatalities in the County of Summit, for the period 10/1/11 through 9/30/12; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute any documents necessary to accept the aforementioned grant and to appropriate grant funds;
