## SECTION 1

County Council hereby determines that the County Executive has demonstrated that it is necessary for the effective and continued operation of the Executive's Department of Environmental Services ("DOES") to authorize the Executive, pursuant to Section 169.04(j) of the Codified Ordinances of the County of Summit, to hire one external person into a full-time, non-bargaining, classified, Engineering Intern position, Category 1 Grade 5, at DOES, at an annual salary not to exceed \$32,177.60.

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further purpose to authorize the County Executive to hire said individual to satisfy an immediate need of support in the Engineering department of DOES, including Computer Aided Design work.

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect and be in force at the earliest time provided by law.
