A Resolution authorizing the County Executive to enter into a three-year policing agreement with Coventry Township, Council District 8, to provide five Sheriff's Deputies and one part-time Direct Indictment officer for twelve hours per week, for the period 1/1/12 through 12/31/14, in the amount of \$595,752.51 for the first year, \$601,863.17 for the second year, and \$605,093.84 for the third year, for a total amount not to exceed \$1,802,709.52 during the three-year term of the agreement, for the Sheriff, and declaring an emergency.

WHEREAS, the County of Summit entered into a policing contract with Coventry Township which terminates 12/31/11; and

WHEREAS, Coventry Township hereby requests that the County enter into a new agreement to provide five Sheriff's Deputies and one part-time Direct Indictment officer for twelve hours per week, for the period 1/1/12 through 12/31/14; and

WHEREAS, Coventry Township has agreed to pay the County \$595,752.51 for the first year, \$601,863.17 for the second year, and the third year \$605,093.84, for a total amount of \$1,802,709.52 during the three-year term of agreement; and

WHEREAS, this Council finds and determines after reviewing all pertinent information that authorizing the Executive to execute the aforementioned policing agreement with Coventry Township is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

SECTION 1

The County Executive is hereby authorized to enter into a three-year policing agreement with Coventry Township, Council District 8, to provide five Sheriff's Deputies and one part-time Direct Indictment officer for twelve hours per week, for the period 1/1/12 through 12/31/14, in the amount of \$595,752.51 for the first year, \$601,863.17 for the second year, and \$605,093.84 for the third year, for a total amount of \$1,802,709.52 during the three-year term of the agreement.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further purpose of immediately authorizing a necessary policing agreement with Coventry Township for 2012 prior to the expiration of the current policing agreement on 12/31/11.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
