7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Oriana House, Inc. for community corrections services for a one-year term,**  
9 **from 1/1/12 through 12/31/12, in an amount not to exceed \$5,320,118.46, with four options**  
10 **to renew for an additional one-year term, with the cost of any renewal term to be equal to**  
11 **the increase in the Consumer Price Index or 3%, whichever is less, over the previous term,**  
12 **for the Executive's Department of Law, Insurance and Risk Management – Division of**  
13 **Public Safety, and declaring an emergency.**

14  
15 WHEREAS, on August 4, 2011, the County of Summit solicited seven providers of  
16 community corrections programs and advertised Requests for Proposals to provide day reporting,  
17 driver intervention, home incarceration, multiple offender and residential community corrections  
18 services; and

19  
20 WHEREAS, on the deadline of September 2, 2011, Oriana House, Inc., was the only  
21 provider to submit a proposal; and

22  
23 WHEREAS, on October 25, 2011, the Criminal Justice Advisory Board voted to  
24 recommend to the County Executive to continue with Oriana House, Inc., as the provider of the  
25 aforementioned services at a 7% cost reduction of the 2011 contract price, to which Oriana  
26 House, Inc., has agreed; and

28 WHEREAS, on November 9, 2011, the Board of Control awarded a professional service  
29 contract to Oriana House, Inc., for community corrections services, subject to confirmation by  
30 County Council; and

32 WHEREAS, this Council finds and determines after reviewing all pertinent information  
33 that it is necessary and in the best interest of the County of Summit to confirm the Board of  
34 Control's award of a professional service contract to Oriana House, Inc., upon the  
35 aforementioned terms and conditions and authorize the County Executive to execute such  
36 contract;

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
39 of Ohio, that:

43 The award by the Board of Control of a professional service contract with Oriana House,  
44 Inc., for community corrections services for a one-year term, from 1/1/12 through 12/31/12, in an  
45 amount not to exceed \$5,320,118.46, with four options to renew for an additional one-year term,  
46 with the cost of any renewal term to be equal to the increase in the Consumer Price Index or 3%,  
47 whichever is less, is hereby confirmed and the County Executive is hereby authorized to execute  
48 such contract.

7 welfare of the citizens of the County of Summit, and for the further purpose to immediately  
8 authorize a contract to provide necessary community corrections services in 2012 where the  
9 current contract for such services expires 12/31/11.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take  
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.

19 It is found and determined that all formal actions of this Council concerning and relating  
20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
21 deliberations of this Council and of any of its committees that resulted in such formal action,

23 121.22 of the Ohio Revised Code.
