7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with The Goodwill Industries of Akron, Ohio, for Workforce Investment Act**  
9 **employment services for adult and dislocated workers and universal employment services,**  
10 **for the period 1/1/12 to 6/30/13, with one option to renew for a one-year period, in an**  
11 **amount not to exceed \$1,307,065.00, for the Executive's Department of Job and Family**  
12 **Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held November 16, 2011, awarded a  
15 contract with The Goodwill Industries of Akron, Ohio, to provide Workforce Investment Act  
16 employment services for adult and dislocated workers and universal employment services, for  
17 the period 1/1/12 to 6/30/13, with one option to renew for a one-year period, in an amount not to  
18 exceed \$1,307,065.00, subject to confirmation by County Council; and,

20 WHEREAS, County Council finds and determines, after reviewing all pertinent  
21 information, that the contract is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

28 The award by the Board of Control of a professional service contract with The Goodwill  
29 Industries of Akron, Ohio, for Workforce Investment Act employment services for adult and  
30 dislocated workers and universal employment services, for the period 1/1/12 to 6/30/13, with one  
31 option to renew for a one-year period, in an amount not to exceed \$1,307,065.00, is hereby  
32 confirmed and the County Executive is hereby authorized to execute such contract.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and  
37 welfare of the citizens of the County of Summit, and for the further purpose to immediately  
38 authorize necessary contracts for Workforce Investment Act employment services within the  
39 Workforce Investment Act grant period.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.
