7 **A Resolution authorizing the County Executive to execute an agreement with James W.**  
8 **and Susan C. Darby, in the amount of \$12,131.00, for an easement on their property, as**  
9 **part of the Whitefriars Sanitary Sewer Improvement Project Q-827 ("Project"), in the**  
10 **Township of Coventry, in Council District 8, for the Executive's Department of**  
11 **Environmental Services, and declaring an emergency.**

13 WHEREAS, County Council previously passed Resolution No. 2011-263, which  
14 approved the detailed plans, specifications and estimate of cost of the Project, which will extend  
15 sanitary sewer down South Main Street and Whitefriars Drive in the Township of Coventry; and

17 WHEREAS, the County of Summit desires to authorize the County Executive to execute  
18 an agreement with James W. and Susan C. Darby, in the amount of \$12,131.00 for an easement  
19 on their property located at 7 Whitefriars Drive in the Township of Coventry, Parcel Nos.  
20 1902696, in Council District 8, as part of the Project; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that that it is necessary and in the best interest of the County of Summit to authorize the County  
24 Executive to execute an agreement with James W. and Susan C. Darby, in the amount of  
25 \$12,131.00, to acquire the aforementioned easement as part of the Project;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
28 of Ohio, that;

32 The County Executive is hereby authorized to execute an agreement with James W. and  
33 Susan C. Darby, in the amount of \$12,131.00, for an easement on their property located at 7  
34 Whitefriars Drive in the Township of Coventry, Parcel No. 1902696, as part of the Whitefriars  
35 Sanitary Sewer Improvement Project Q-827 ("Project"), and to accept said easement for the  
36 County of Summit, in Council District 8.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and  
41 welfare of the citizens of the County of Summit and for the purpose of allowing construction of  
42 the Project to proceed immediately.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval of the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.
