12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the Jail Cell Intercom
16 Project, in Council District 5, for an estimated total cost not to exceed \$584,000.00; and

18 WHEREAS, a copy of the drawings and specifications are on file in the office of the
19 Clerk of Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that is necessary and in the best interest of the County of Summit to authorize the Executive to
23 advertise for bids for the aforementioned project;

30 The County Executive is authorized to advertise for bids for the Jail Cell Intercom

36 of the citizens of the County of Summit, and for the further reason that it authorizes the
37 Executive to immediately advertise for bids for the Jail Cell Intercom Project in order to meet
38 appropriate deadlines for the expenditure of funds borrowed to finance this project.
