WHEREAS, pursuant to the County of Summit's authority to regulate businesses in the unincorporated areas of the County, County Council previously adopted Amended Ordinance No. 2010-160 and Ordinance Nos. 2010-262 and 2011-072 to enact Chapter 755 of the Codified Ordinances of the County of Summit, entitled "Entertainment Device Arcades," to regulate entertainment device arcades through the County's Office of Consumer Affairs; and

WHEREAS, on October 12, 2011, the Village of Boston Heights adopted Ordinance No. 23-2011, which enacted Chapter 711 of the Village's Codified Ordinances to regulate entertainment device arcades in the Village; and

WHEREAS, the Village wishes to have the Office of Consumer Affairs act as administrative agent for the enforcement of Chapter 711; and

WHEREAS, the County and the Village have negotiated an Intergovernmental Agreement under which the Office of Consumer Affairs will act administrative agent for enforcement of Chapter 711in exchange for 25% of the license fees collected; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute an Intergovernmental Agreement between the County and the Village for the aforementioned purposes;

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Council of the County of Summit, State of Ohio, that:
