7 **A Resolution confirming an award by the Board of Control for the first amendment of a**
8 **service agreement with Motorola, Inc., as Best Practical Source, for the 800 MHz Regional**
9 **Radio System, for the period 9/1/13 through 12/31/13, in an amount not to exceed**
10 **\$34,882.60, for the Executive's Department of Law, Insurance and Risk Management,**
11 **Division of Public Safety, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held 1/2/13, awarded the first
14 amendment of a service agreement with Motorola, Inc., as Best Practical Source, for the 800
15 MHz Regional Radio System, for the period 9/1/13 through 12/31/13, subject to confirmation by
16 County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the first amendment of the aforementioned service agreement is necessary and in the best
20 interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
23 of Ohio, that:

27 The award by Board of Control of the first amendment of a service agreement with
28 Motorola, Inc., as Best Practical Source, for the 800 MHz Regional Radio System, for the period
29 9/1/13 through 12/31/13, in an amount not to exceed \$34,882.60, is hereby confirmed and the
30 County Executive is hereby authorized to execute such amendment.

34 This Resolution is declared an emergency in the interest of the health, safety and welfare
35 of the citizens of the County of Summit and for the further purpose of immediately providing a
36 necessary service agreement for the 800 MHz Regional Radio System which serves public safety
37 entities throughout Summit County.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and of any of its committees that resulted in such formal action,
