7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award by the Ohio Department of Public Safety of a Paul Coverdell National**  
9 **Forensic Sciences Improvement Act of 2000 funding, for the National Forensic Science**  
10 **Improvement Training grant, in the amount of \$2,411.70, with no local cash match**  
11 **requirement, for the period 10/1/12 through 12/31/13, and appropriating these funds for**  
12 **2013, for the Medical Examiner, and declaring an emergency.**

14 WHEREAS, the County Medical Examiner has received a Coverdell National Forensic  
15 Science Improvement Training grant award from the Ohio Department of Public Safety  
16 ("ODPS"), for the period 10/1/12 through 12/31/13, in the amount of \$2,411.70, with no local  
17 cash match requirement; and

19 WHEREAS, this funding will provide for travel, training and conference expenses to the  
20 American Academy of Forensic Sciences Annual conference in Washington, DC; and

22 WHEREAS, this Council find and determines, after reviewing all pertinent information,  
23 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
24 execute any documents necessary to accept the award of the aforementioned grant from ODPS,  
25 and to appropriate these grant funds;

32 The County Executive is hereby authorized to execute any documents necessary to accept
