10 **A Resolution confirming an award by the Board of Control of a professional service**  
11 **contract with the County of Summit Clerk of Courts for a IV-D provider contract to**  
12 **provide federal financial participation reimbursement to the Clerk of Courts for filing**  
13 **services and expenses directly related to the County of Summit Child Support Enforcement**  
14 **Agency, for the period 1/1/13 through 12/31/13, in an amount not to exceed \$139,517.34, for**  
15 **the Prosecutor's Child Support Enforcement Agency, and declaring an emergency.**

17 WHEREAS, the Board of Control, at its meeting held January 23, 2013, awarded a  
18 professional service contract with the County of Summit Clerk of Courts for a IV-D provider  
19 contract to provide federal financial participation reimbursement to the Clerk of Courts for filing  
20 services and expenses directly related to the County of Summit Child Support Enforcement  
21 Agency, for the period 1/1/13 through 12/31/13, subject to confirmation by County Council; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that the aforementioned contract is necessary and in the best interest of the County of Summit;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
27 of Ohio, that:

31 The award by the Board of Control of a professional service contract with the County of  
32 Summit Clerk of Courts for a IV-D provider contract to provide federal financial participation  
33 reimbursement to the Clerk of Courts for filing services and expenses directly related to the  
34 County of Summit Child Support Enforcement Agency, for the period 1/1/13 through 12/31/13,  
35 in an amount not to exceed \$139,517.34, is hereby confirmed and the County Executive is  
36 hereby authorized to execute such contract.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and  
41 welfare of the citizens of the County of Summit, and for the further purpose of immediately  
42 providing reimbursements to the County of Summit Clerk of Courts effective 1/1/13.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
effect and be in force at the earliest time provided by law.


