7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Inspiron Logistics for a one-year renewal of a service agreement for the**
9 **Wireless Emergency Notification System, for public safety agencies throughout Summit**
10 **County, as Sole Source, in an amount not to exceed \$26,750.00, for the Executive's**
11 **Department of Law, Insurance and Risk Management – Emergency Management Agency,**
12 **and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held January 16, 2013, awarded a
15 professional service contract with Inspiron Logistics for a one-year renewal of a service
16 agreement for the Wireless Emergency Notification System, for public safety agencies
17 throughout Summit County, as Sole Source, subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that the contract is necessary and in the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
23 of Ohio, that:

27 The award by the Board of Control of a professional service contract with Inspiron
28 Logistics for a one-year renewal of a service agreement for the Wireless Emergency Notification
29 System, for public safety agencies throughout Summit County, as Sole Source, in an amount not
30 to exceed \$26,750.00, is hereby confirmed and the County Executive is hereby authorized to
31 execute such contract.

33 SECTION 2

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit, and for the further reason to immediately
37 provide for the renewal of the service agreement.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this Council concerning and relating
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and of any of its committees that resulted in such formal action,
50 were in meetings open to the public, in compliance with all legal requirements, including Section
51 121.22 of the Ohio Revised Code.
