7 **A Resolution authorizing the County Executive to conduct an auction, through Skipco**
8 **Auto Auction, of 28 surplus County vehicles with a total fair market value exceeding**
9 **\$15,000.00, for a cost to the County of an amount not to exceed \$5,000.00, and authorizing**
10 **the Executive to execute any documents with Skipco Auto Auction necessary to conduct**
11 **said auction, for the Executive, and declaring an emergency.**

13 WHEREAS, the County has 28 vehicles that have been declared surplus personal
14 property by Executive Order; and

15
16 WHEREAS, the County wishes to auction said vehicles, which have a total fair market
17 value exceeding \$15,000.00, which requires the approval of County Council pursuant to Section
18 177.19 of the Codified Ordinances of the County of Summit; and

20 WHEREAS, the County Executive intends to conduct said auction through Skipco Auto
21 Auction at a cost to the County of \$115.00 per vehicle for the auction and \$45.00 per vehicle for
22 pick-up, for a total cost to the County of an amount not to exceed \$5,000.00; and

24 WHEREAS, it is necessary to authorize the Executive to execute any documents with
25 Skipco Auto Auction necessary to conduct said auction; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to authorize the County
29 Executive to conduct an auction, through Skipco Auto Auction, of 28 surplus County vehicles
30 with a total fair market value exceeding \$15,000.00, for a cost to the County of an amount not to
31 exceed \$5,000.00, and to authorize the Executive to execute any documents with Skipco Auto
32 Auction necessary to conduct said auction;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 The County Executive hereby authorized to conduct an auction, through Skipco Auto
40 Auction, of 28 surplus County vehicles, listed in Exhibit A, attached hereto and incorporated
41 herein as if fully restated, with a total fair market value exceeding \$15,000.00. The cost to the
42 County shall not exceed the amount of \$115.00 per vehicle for the auction and \$45.00 per
43 vehicle for pick-up, for a total cost to the County of an amount not to exceed \$5,000.00. The
44 Executive is further authorized to execute any documents with Skipco Auto Auction necessary to
45 conduct said auction.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and
7 welfare of the citizens of the County of Summit and for further purpose of immediately
8 authorizing the Executive to conduct an auction of 28 surplus County vehicles through Skipco
9 Auto Auction.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.
