7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract renewal (second of two) with Quality Control Inspection, Inc., for construction**
9 **inspection services throughout Summit County, for the period 1/1/13 through 12/31/13, in**
10 **an amount not to exceed \$75,000.00, for the Engineer, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held February 6, 2013, awarded a
13 professional service contract renewal (second of two) with Quality Control Inspection, Inc., for
14 construction inspection services throughout Summit County, for the period 1/1/13 through
15 12/31/13, subject to confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the contract renewal is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The award by the Board of Control of a professional service contract renewal (second of
26 two) with Quality Control Inspection, Inc., for construction inspection services throughout
27 Summit County, for the period 1/1/13 through 12/31/13, in an amount not to exceed \$75,000.00,
28 is hereby confirmed and the County Executive is hereby authorized to execute such contract
29 renewal.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further purpose of immediately
35 ensuring that construction inspectors are available for all capital and new subdivision projects.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
