7 **A Resolution confirming an award by the Board of Control of a purchase order with**
8 **METRO Regional Transit Authority for 31-day and 1-day bus passes for work-mandated**
9 **clients, for the period 1/1/13 through 12/31/13, as Best Practical Source, in an amount not**
10 **to exceed \$180,000.00, for the Executive's Department of Job and Family Services, and**
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held February 27, 2013, awarded a
14 purchase order with METRO Regional Transit Authority for 31-day and 1-day bus passes for
15 work-mandated clients, for the period 1/1/13 through 12/31/13, as Best Practical Source, subject
16 to confirmation by County Council; and,

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the purchase order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of a purchase order with METRO Regional Transit
27 Authority for 31-day and 1-day bus passes for work-mandated clients, for the period 1/1/13
28 through 12/31/13, as Best Practical Source, in an amount not to exceed \$180,000.00, is hereby
29 confirmed and the County Executive is hereby authorized to execute such purchase order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide bus passes for cash assistance eligible clients for the period beginning 1/1/13.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,

49 121.22 of the Ohio Revised Code.


