10 **requirement, for Fiscal Year 2013, for the Executive's Department of Community and**  
11 **Economic Development and declaring an emergency.**

13 WHEREAS, the PNC Bank Foundation has donated \$10,000.00, for the Moving Ohio  
14 Forward Program, as a grant to the Summit County Land Reutilization Corporation, for  
15 demolition projects in the Village of Lakemore; and

17 WHEREAS, these funds are to be administered by the County of Summit Department of  
18 Community and Economic Development; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that it is necessary and in the best interest of the County of Summit to appropriate the  
22 aforementioned funds in the total amount of \$10,000.00, with no local cash match requirement;

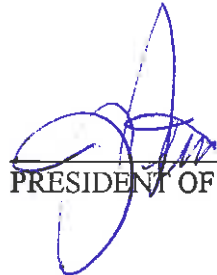
