8 **Summit County Public Health for the County Sheriff's Office to provide one Sheriff's**
9 **Deputy for community based policing, on a per unit basis, related to an Adult Protective**
10 **Services Pilot Project, from 10/1/12 through 9/30/13, with one option to renew for an**
11 **additional one-year term, for a total amount not to exceed \$90,000.00, for the Sheriff, and**
12 **declaring an emergency.**

14 WHEREAS, Summit County Public Health wishes to execute a one-year agreement with
15 the County of Summit for the County Sheriff's Office to provide one Sheriff's Deputy for
16 community based policing, on a per unit basis, related to an Adult Protective Services Pilot
17 Project, from 10/1/12 through 9/30/13, with one option to renew for an additional one-year term,
18 for a total amount not to exceed \$90,000.00; and

20 WHEREAS, the Sheriff wishes to provide one Deputy for the aforementioned purpose;

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that the aforementioned agreement is necessary and in the best interest of the County of Summit;

31 The County Executive is hereby authorized to execute to execute a one-year agreement
32 with Summit County Public Health for the County Sheriff's Office to provide one Sheriff's
33 Deputy for community based policing, on a per unit basis, related to an Adult Protective Services
34 Pilot Project, from 10/1/12 through 9/30/13, with one option to renew for an additional one-year
35 term, for a total amount not to exceed \$90,000.00.

39 This Resolution is hereby declared an emergency in the interest of the health, safety, and
40 welfare of the citizens of the County of Summit and for the further purpose of immediately
41 authorizing the execution of an agreement for the Sheriff Office to provide one Deputy Sheriff
42 for community based policing, on a per unit basis, to Summit County Public Health, related to an
43 Adult Protective Services Pilot Project.
