7 **An amended Ordinance amending Sections ~~169.07, 169.08~~, 169.15, 169.22 and 169.28 of the**  
8 **Codified Ordinances of the County of Summit, for the Executive's Department of Human**  
9 **Resources, and declaring an emergency.**

11 WHEREAS, representatives from County offices have made certain recommendations for  
12 revisions to Chapter 169 of the Codified Ordinances of the County of Summit, entitled  
13 "Personnel Policies and Procedures;" and

14  
15 WHEREAS, said recommendations have been reviewed and approved by the Executive's  
16 Department of Human Resources; and

17  
18 WHEREAS, on February 4, 2013, the Human Resource Commission adopted Order No.  
19 13-01, approving the recommended revisions to Chapter 169; and

20  
21 WHEREAS, having reviewed the same, this Council has elected to adopt certain of the  
22 revisions, specifically amendments to Section 169.15, 169.22 and 169.28 of the Codified  
23 Ordinances of the County of Summit, and will consider the balance of the recommendations at a  
24 later date; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
27 that it is necessary and in the best interest of the County of Summit to adopt said  
28 recommendation and amend Sections ~~169.07, 169.08~~, 169.15, 169.22 and 169.28 of the Codified  
29 Ordinances of the County of Summit;

31 NOW, THEREFORE, BE IT ORDNAINED, by the Council of the County of Summit,  
32 State of Ohio, that:

34 SECTION 1

36 Sections ~~169.07, 169.08~~, 169.15, 169.22 and 169.28 of the Codified Ordinances of the  
37 County of Summit are hereby amended as set forth in Amended Exhibit A, attached hereto and  
38 incorporated herein by reference.

40 SECTION 2

42 The Ordinance is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the citizens of the County of Summit, and for the further reason of immediately  
44 amending Chapter 169 in order to immediately implement a more efficient human resource  
45 system in the County.

47 SECTION 3

49 Provided this Ordinance receives the affirmative vote of eight members, it shall take  
50 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect  
51 and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


