7 **A Resolution appropriating the amount of \$5,981.64 in probation improvement grant**  
8 **funds, from the Ohio Department of Rehabilitation and Correction, with no local cash**  
9 **match requirement, for the period ending 4/15/13, for the Court of Common Pleas -**  
10 **General Division, and declaring an emergency.**

11  
12 WHEREAS, the Ohio Department of Rehabilitation and Correction awarded and paid  
13 \$199,100.00 to the County of Summit Court of Common Pleas – General Division for a  
14 probation improvement training and technology grant, with a program end date of 12/31/12; and

15  
16 WHEREAS, the grant program expended \$196,217.27, with an unspent balance of  
17 \$2,882.73 that is required to be refunded to the State of Ohio; and

18  
19 WHEREAS, the grant program had payroll salary and benefit expenses of \$3,098.91  
20 earned in 2012 but paid in the 1/4/13 payroll which must now be appropriated in 2013; and

21  
22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that it is necessary and in the best interest of the County of Summit to appropriate the  
24 aforementioned funds in the total amount of \$5,981.64, with no local cash match requirement;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State




