7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award of federal funds from the Ohio Department of Job and Family Services of**
9 **a 2013 Connecting the Dots Temporary Assistance for Needy Families Demo grant, for the**
10 **period ending 6/30/13, in the amount of \$70,000.00, with no local cash match requirement,**
11 **and appropriating the total for expenditures in 2013, for the Executive's Department of**
12 **Job and Family Services, and declaring an emergency.**

14 WHEREAS, the Summit County Department of Job and Family Services ("SCDJFS")
15 has received an award of a 2013 Connecting the Dots Temporary Assistance for Needy Families
16 ("TANF") Demo grant from the Ohio Department of Job and Family Services ("ODJFS"), of
17 federal funds in the amount of \$70,000.00, with no local cash match requirement; and

19 WHEREAS, these funds will enable SCDJFS to operate a Connecting the Dots program
20 with the purpose of improving the educational and employment outcomes for Summit County
21 youth aging out of foster care and supporting their transition to adulthood; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
25 execute any documents necessary to accept the award of the aforementioned grant from ODJFS
26 and to appropriate these grant funds;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

33 The County Executive is hereby authorized to execute any documents necessary to accept
34 the award of a 2013 Connecting the Dots Temporary Assistance for Needy Families ("TANF")
35 Demo grant award from the Ohio Department of Job and Family Services ("ODJFS"), for the
36 period ending 6/30/13, in the amount of \$70,000.00, with no local cash match requirement.

29 121.22 of the Ohio Revised Code.


