7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a Justice Assistance Grant award from the Ohio Office of Public Safety/Office of**
9 **Criminal Justice Services, for the Summit County Drug Unit, in the amount of \$72,391.90,**
10 **with a 25% local cash match requirement of \$24,130.61, for the period 1/1/13 through**
11 **12/31/13, and appropriating the total of \$96,522.51, through calendar year 2013, for the**
12 **Sheriff, and declaring an emergency.**

14 WHEREAS, the Ohio Office of Public Safety/Office of Criminal Justice Services has
15 awarded a Justice Assistance Grant ("JAG"), to the Summit County Drug Unit program, in the
16 amount of \$72,391.90, which requires a 25% local cash match of \$24,130.61, for a project total
17 of \$96,522.51, for the period 1/1/13 through 12/31/13; and

19 WHEREAS, this annual funding supports a Sheriff's lieutenant position for the Drug
20 Unit operations; and

22 WHEREAS, the local cash match funding will be paid from the Sheriff's Drug Unit
23 checking account funds; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
27 execute any documents necessary to accept the award of the aforementioned grant from the Ohio
28 Office of Public Safety/Office of Criminal Justice Services, and to appropriate these grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

36 the Justice Assistance Grant ("JAG") for the Summit County Drug Unit Program, from the Ohio

38 12/31/13, in the amount of \$72,391.90, with a \$24,130.61 local cash match requirement.

SECTION 3

SECTION 4

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason to immediately authorize the Executive to execute any documents necessary to accept the Sheriff's JAG Drug Unit grant award and to appropriate the Drug Unit grant funds in order to meet the State of Ohio's time frame requirements.

SECTION 5

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
