10 **Division, and declaring an emergency.**

12 WHEREAS, the County of Summit Court of Common Pleas - Juvenile Division, is in  
13 receipt of Title IV-E reimbursement funds from the Ohio Department of Job and Family  
14 Services; and

16 WHEREAS, these funds are to be used for out-of-home placement costs of services and  
17 care for troubled youth when it is contrary to their best interests to remain in their homes; and

19 WHEREAS, this Council finds and determines, after by reviewing all pertinent  
20 information, that it is necessary and in the best interest of the County of Summit to appropriate  
21 the aforementioned funds in the total amount of \$200,000.00, with no local cash match  
22 requirement;
