12 WHEREAS, the Board of Control, at its meeting held May 1, 2013, awarded a purchase
13 order with Hewlett Packard for three servers and a storage array system, approved by the IT
14 Board 4/23/13, under State Term Pricing, subject to confirmation by County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the purchase order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of a purchase order with Hewlett Packard for three
25 servers and a storage array system, approved by the IT Board 4/23/13, under State Term Pricing,
26 in an amount not to exceed \$33,282.45, is hereby confirmed and the County Executive is hereby
27 authorized to execute such purchase order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 upgrade the servers in the Court of Common Pleas – Probate Division.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.
