A Resolution authorizing the County Executive to execute any documents necessary to accept an award of federal funds from the National Court Appointed Special Advocate Association, of a 2013 National Court Appointed Special Advocate Association Youth Advocacy Local grant, for the period 6/1/13 through 5/31/14, in the amount of \$40,000.00 with no local match requirement, and appropriating the grant with a local cash supplement of \$25,636.00, for a programming total of \$65,636.00 for expenditures in 2013, for the Court of Common Pleas-Juvenile Division, and declaring an emergency.

WHEREAS, the National Court Appointed Special Advocate Association (National CASA) has award the Court of Common Pleas-Juvenile Division (Juvenile Court) a Youth Advocacy grant of federal funds in the amount of \$40,000.00, with no local cash match requirement; and

WHEREAS, the Juvenile Court will supplement the program funding with available Title IV-E funds in the amount of \$25,636.00, from the Ohio Department of Job and Family Services (ODJFS) awarded for the provision of services for troubled youth outside the home; and

WHEREAS, National CASA is a not-for-profit organization which offers consultation and resources to help provide programs for abused and neglected children; and

WHEREAS, Juvenile Court maintains a CASA program (Summit County CASA) to provide every child who enters the court system, as a result of allegations of abuse, neglect or dependency, with a trained volunteer to advocate in court for what is in the child's best interest; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the award of the aforementioned grant from the National Court Appointed Special Advocate Association, and to appropriate the grant funds and the supplemental funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute any documents necessary to accept the award of a 2013 National Court Appointed Special Advocate Association Youth Advocacy Local grant award from the National Court Appointed Special Advocate Association, for the period 6/1/13 through 5/31/14, in the amount of \$40,000.00, with no local cash match requirement.


