7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, ratifying purchases by the County Executive in calendar year 2013 from Wolff**
9 **Brothers Supply, Inc. for replacement parts and materials for numerous operations within**
10 **the County Executive's Office, in the aggregate amount of \$32,040.94, and authorizing**
11 **additional purchases in an amount not to exceed \$94,000.00, for a total aggregate amount**
12 **not to exceed \$126,040.94, for calendar year 2013, for the Executive's Departments of**
13 **Environmental Services, Administrative Services and Job and Family Services, and**
14 **declaring an emergency.**

16 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
17 requires that purchases by an officeholder exceeding \$25,000.00 in aggregate in any calendar
18 year, where no additional competitive quotes or bids have been taken, shall be made only upon
19 authorization of County Council; and

21 WHEREAS, the Department of Finance and Budget and the Board of Control have
22 previously approved purchases by the County Executive in calendar year 2013 in aggregate
23 totaling \$32,040.94 for the Departments of Environmental Services, Administrative Services and
24 Job and Family Services with Wolff Brothers Supply, Inc. for replacement parts and materials
25 for numerous operations within the County Executive's Office; and

27 WHEREAS, the Departments of Environmental Services, Administrative Services and
28 Job and Family Services anticipate that the County Executive will make additional purchases in
29 calendar year 2013 from Wolff Brothers Supply, Inc. for replacement parts and materials in an
30 additional amount not to exceed \$94,000.00, for a total aggregate amount not to exceed
31 \$126,040.94 in calendar year 2013; and

33 WHEREAS this Council finds and determines, after reviewing all pertinent information,
34 that it is necessary and in the best interest of the County to ratify purchases by the County
35 Executive in calendar year 2013 from Wolff Brothers Supply, Inc. for replacement parts and
36 materials for numerous operations within the County Executive's Office in the aggregate amount
37 of \$32,040.94, and to authorize additional purchases in an amount not to exceed \$94,000.00, for
38 a total aggregate amount not to exceed \$126,040.94, for calendar year 2013.
