13 WHEREAS, the Board of Control, at its meeting held June 5, 2013, awarded various
14 professional service contracts with providers per attached Exhibit A, for Fiscal Year 2014
15 Delinquent Care and Custody Grant contracts, for the period 7/1/13 through 6/30/14, subject to
16 confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contracts are necessary and in the best interest of the County of Summit;

27 providers per attached Exhibit A, for Fiscal Year 2014 Delinquent Care and Custody Grant
28 contracts, for the period 7/1/13 through 6/30/14, in a total amount not to exceed \$1,358,896.00,
29 is hereby confirmed and the County Executive is hereby authorized to execute such contracts.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for the contracts effective 7/1/13.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
