12 WHEREAS, the Board of Control, at its meeting held July 3, 2013, awarded a purchase
13 contract renewal (second of three) to provide inmate pay phone services at the County of Summit
14 Jail, for the period 7/15/13 through 7/14/14; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the contract renewal is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The County Executive is hereby authorized to execute a purchase contract renewal
25 (second of three) with Inmate Calling Solutions, LLC, dba ICSolutions, for inmate pay phone
26 services at the County of Summit Jail, for the period 7/15/13 through 7/14/14, at a commission
27 rate of 70%, is hereby confirmed and the County Executive is hereby authorized to execute such
28 renewal.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further purpose to immediately
34 provide inmate phone services at the County Jail effective 7/15/13.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,


