7 **A Resolution appropriating \$376,901.22 within the Sheriff's Policing Rotary Fund to**
8 **increase funding for four new policing contracts and to cover salaries and other expenses**
9 **for those contracts, for the fiscal year ending 12/31/13, for the Sheriff, and declaring an**
10 **emergency.**

11
12 WHEREAS, the County Sheriff's Policing Rotary Fund was established to receive
13 revenue from communities and agencies requesting the Sheriff's policing services; and

14
15 WHEREAS, the Sheriff's Policing Rotary Fund has received four new contracts since the
16 budget was certified, including two Developmental Disabilities Board contracts totaling
17 \$197,895.22, one Summit County Public Health contract for \$90,000.00, and one Summit
18 County Children Services Board contract for \$20,000.00, for a total amount of \$307,895.22; and

20 WHEREAS, the Sheriff's Policing Rotary Fund's proportionate share of the Maximus
21 indirect cost allocation totals \$69,006.00, which was not previously budgeted; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to appropriate funds, in the
25 total amount of \$376,901.22;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:




