7 **A Resolution authorizing the County Executive to execute an agreement with the City of**  
8 **Akron and sign any documents necessary to accept an award of grant funds from the City**  
9 **of Akron, for the furtherance of the Metropolitan Medical Response System of Summit**  
10 **County, for the Executive's Department of Law, Insurance and Risk Management -**  
11 **Division of Public Safety/Emergency Management Agency and declaring an emergency.**

13 WHEREAS, in 2000, the Akron Health Department received funds by agreement with  
14 the U.S. Department of Health and Human Services to establish the Metropolitan Medical  
15 Response System ("MMRS") of Summit County, which funds were held by the City of Akron as  
16 fiscal agent; and

17  
18 WHEREAS, in 2007, the Summit County Emergency Management Agency became  
19 responsible for operation of MMRS and also became the fiscal agent: and

20  
21 WHEREAS, funds remain with the City of Akron from the initial agreement in the  
22 amount of \$280,739.00 which are held by the City of Akron; and

23  
24 WHEREAS, the City of Akron and the County of Summit desire to enter into an  
25 agreement whereby said funds will be transferred to the County, and the County, through the  
26 Emergency Management Agency, will expend said funds to further the operation of MMRS; and

27  
28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
30 execute the aforementioned agreement;

32 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
33 State of Ohio, that:

35 SECTION 1

36  
37 The County Executive is hereby authorized to execute an agreement with the City of  
38 Akron and sign any documents necessary to accept an award of grant funds in the amount of  
39 \$280,739.00 from the City of Akron to be held by the Summit County Emergency Management  
40 Agency as fiscal agent for the Metropolitan Medical Response System ("MMRS") of Summit  
41 County. Said funds will be used exclusively for the purpose of further operation of the MMRS.

43 SECTION 2

45 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
46 welfare of the citizens of the County of Summit, and for the further purpose of immediately  
47 continuing the operation of the MMRS.

16 121.22 of the Ohio Revised Code.


