A Resolution authorizing the County Executive to disburse funds, including funds that exceed an aggregate amount of \$25,000.00 to a vendor, to all Non-Emergency Medical Transportation providers operating under contract with the Executive's Department of Job and Family Services, to provide payment for invoices received from providers for Non-Emergency Medical Transportation services to residents who are deemed eligible for Medicaid services, in Federal Fiscal Year 2014, for the period 10/1/13 through 9/30/14, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, Section 177.21 of the Codified Ordinances of the County of Summit requires the approval of County Council for all contracts with a vendor exceeding \$25,000.00 in the aggregate in any calendar year which are funded by State of Ohio or federal pass-through dollars for which the County has no discretion in selecting the vendor; and

WHEREAS, the Executive's Department of Job and Family Services ("DJFS") coordinates and monitors Non-Emergency Medical Transportation ("NET") services for eligible Summit County Medicaid clients through NET providers via portal-to-portal transportation which is funded by federal pass-through Medicaid dollars; and

WHEREAS, DJFS is responsible for providing the payment of invoices received from NET providers who have provided NET services to Summit County residents deemed eligible by DJFS for Medicaid services; said payments being funded by federal pass-through Medicaid dollars; and

WHEREAS, it is necessary to exceed an aggregate of \$25,000.00 in Federal Fiscal Year ("FFY") 2014 for the disbursements of the pass-through funds to some providers under the above-referenced programs; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to authorize the County Executive to disburse pass-through funds exceeding \$25,000.00 to NET providers under the above-referenced program;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to enter into various contracts with Non-Emergency Medical Transportation ("NET") providers to disburse pass-through funds exceeding an aggregate amount off \$25,000.00 to a vendor for the payment of invoices for reimbursement of NET services provided to eligible residents during Federal Fiscal Year ("FFY") 2014, for the period 10/1/13 through 9/30/14.
