7 **A Resolution authorizing the Executive to execute any documents necessary to accept an**
8 **award from the U.S. Department of Justice, Office of Juvenile Justice and Delinquency**
9 **Prevention of a Family Drug Court Implementation Project grant, for the Fiscal Years**
10 **2014 through 2016, in the amount of \$538,363.00, with no local cash match requirement,**
11 **and appropriating these grant funds for the period of 10/1/13 through 9/30/16, for the**
12 **Court of Common Pleas- Juvenile Division, and declaring an emergency.**

14 WHEREAS, the County of Summit Court of Common Pleas- Juvenile Division has been
15 awarded a Family Drug County Implementation Project grant, from the U.S. Department of
16 Justice, Office of Juvenile Justice and Delinquency Prevention ("OJJDP"), for the funding of a
17 local collaborative in providing services to families, in the amount of \$538,363.00, with no local
18 cash match requirement; and

20 WHEREAS, the Family Drug Court Implementation Project is a collaboration with
21 Summit County Children Services and a myriad of local service providers; and

23 WHEREAS, the goal of this funding is to partner with families to address substance
24 abuse and other family challenges to create a healthy, stable home environment and permanently
25 reunify the family; and

27 WHEREAS, it is necessary to appropriate said grant funds for the period 10/1/13 through
28 9/30/16; and

30 WHEREAS, this Council has determined, after reviewing all pertinent information that it
31 is necessary and in the best interest of the County to authorize the Executive to execute any
32 documents necessary to accept the award of the aforementioned grant and to appropriate these
33 grant funds;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

40 The Executive is hereby authorized to execute any documents necessary to accept an
41 award from the U.S. Department of Justice, Office of Juvenile Justice and Delinquency

43 2016, in the amount of \$538,363.00, with no local cash match requirement.


