7 **A Resolution authorizing the County Executive to advertise for bids for the purchase of**
8 **two utility service bodies for Ford F-550 chassis cabs, for an estimated total cost not to**
9 **exceed \$35,000.00, for the Executive's Department of Environmental Services, and**
10 **declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

14
15 WHEREAS, in Resolution No. 2013-408, this Council recently approved the purchase of
16 various vehicles to replace unreliable and inoperable equipment in the Executive's Department
17 of Environmental Services ("DOES") fleet, including two Ford 550 four-wheel drive trucks; and

18
19 WHEREAS, the new Ford F-550 trucks require utility service bodies, large tool and
20 supply boxes, in order to be properly equipped and effective in their purpose; and

21
22 WHEREAS, the County Executive wishes to advertise for bids for the purchase of two
23 utility service bodies for Ford F-550 chassis cabs, for an estimated total cost not to exceed
24 \$35,000.00, for DOES; and

26 WHEREAS, a copy of the technical specifications are attached as Exhibit A; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that authorizing the County Executive to advertise for bids for the aforementioned utility service
30 bodies is necessary and in the best interest of the County of Summit;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that;

35 SECTION 1

37 The County Executive is authorized to advertise for bids for the purchase of two utility
38 service bodies for Ford F-550 chassis cabs, for an estimated total cost not to exceed \$35,000.00.

40 SECTION 2

42 This Resolution is declared an emergency in the interest of the health, safety, and welfare
43 of the citizens of the County of Summit, and for the further reason that it authorizes the
44 Executive to immediately advertise for bids for the utility service bodies, needed to properly
45 equip the two new Ford F-550 trucks in the Executive's Department of Environmental Services
46 ("DOES") fleet.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
52 effect and be in force at the earliest time provided by law.


