7 **A Resolution of support for the Northeast Ohio Four County Regional Planning and**
8 **Development Organization’s 2014 Comprehensive Economic Development Strategy, for the**
9 **Executive, and declaring an emergency.**

11 WHEREAS, the Public Works and Economic Development Act of 1965, 42 U.S.C.
12 Sections 3132-3233, as amended, delegates to the Economic Development Administration
13 (“EDA”) responsibility of assisting in the development of multi-county planning districts
14 through project grants which assure effective utilization of local resources in creating full-time
15 permanent jobs for the unemployed and the underemployed; and

16
17 WHEREAS, the purpose of the 1998 amendment to the Act was to further authorize
18 economic assistance in the form of planning and implementation grants under Title I and II to
19 areas experiencing unemployment caused by structural changes in the area’s economy; and

20
21 WHEREAS, the EDA is authorized through planning and implementation grants to assist
22 area planning efforts to solve problems of economic growth, unemployment and
23 underemployment; and

25 WHEREAS, the Northeast Ohio Four County Regional Planning and Development
26 Organization (“NEFCO”) General Policy Board, in conjunction with its 126 local units of
27 government, has formulated the 2014 Comprehensive Economic Development Strategy
28 (“CEDS”); and

30 WHEREAS, enabling legislation of the EDA requires the submittal of the NEFCO CEDS
31 Report to EDA, which includes a list of Summit County projects, attached hereto as Exhibit A
32 and incorporated herein as if fully restated, to maintain economic development district
33 designation; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
36 that it is necessary and in the best interest of the County of Summit that the County affirms its
37 support for NEFCO’s 2014 CEDS;

39 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
40 of Ohio, that:




