7 **A Resolution authorizing the County Executive to advertise for bids for uniforms and their**  
8 **cleaning for 13 inspectors, for the period 1/1/14 through 12/31/18, for an estimated total**  
9 **cost not to exceed \$40,000.00, for the Executive’s Department of Community and Economic**  
10 **Development – Building Standards Division, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council’s authorization for the County Executive to advertise for bids; and

14  
15 WHEREAS, the County Executive wishes to advertise for bids for uniforms and their  
16 cleaning for 13 inspectors, for the period 1/1/14 through 12/31/18, for an estimated total cost not  
17 to exceed \$40,000.00; and

19 WHEREAS, a copy of the specifications are on file with the Clerk of Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
23 advertise for bids for uniforms and their cleaning for 13 inspectors of the Building Standards  
24 Division, for the period 1/1/14 through 12/31/18;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
27 of Ohio, that;

29 SECTION 1

31 The County Executive is authorized to advertise for bids for uniforms and their cleaning  
32 for 13 inspectors of the Executive’s Department of Community and Economic Development –  
33 Building Standards Division, for the period 1/1/14 through 12/31/18, for an estimated total cost  
34 not to exceed \$40,000.00.

38 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
39 of the citizens of the County of Summit, and for the further reason that it authorizes the  
40 Executive to immediately advertise for bids for uniforms and their cleaning for 13 inspectors of  
41 the Executive’s Department of Community and Economic Development – Building Standards  
42 Division, before the expiration of the current contract on 12/31/13.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.
