7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Akron Legal News, Inc., to provide publication of notices of Sheriff sales and**  
9 **other necessary legal notices, with funds being collected up front by the Clerk of Courts,**  
10 **for the period 1/1/14 through 12/31/18, with two five-year renewal options, for the**  
11 **Executive's Department of Law, Insurance and Risk Management, and declaring an**  
12 **emergency.**

14 WHEREAS, the County, upon reviewing responses to a request for proposals, has  
15 determined that the proposal received by Akron Legal News is the most cost-effective provider  
16 of publication services for notices of Sheriff sales; and

17  
18 WHEREAS, the Board of Control, at its meeting held October 16, 2013, awarded a  
19 professional service contract to Akron Legal News for publication of notices of Sheriff sales and  
20 other necessary legal notices pursuant to Sections 2329.26 and 2329.27 of the Ohio Revised  
21 Code, for the period 1/1/14 through 12/31/18, with two five-year renewal options; subject to  
22 confirmation by County Council; and

24 WHEREAS, the Court of Common Pleas establishes a fee schedule which includes the cost  
25 of such notices, which cost is collected by the Clerk of Courts as part of the filing fees in each  
26 case where such notice may be necessary; and

28 WHEREAS, the Court of Common Pleas has, by Miscellaneous Order, approved the use  
29 of Akron Legal News for the provision of such services; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
32 that it is necessary and in the best interest of the County to confirm the award of the  
33 aforementioned contract.

35 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
36 of Ohio, that:

40 The award by the Board of Control of a professional service contract with Akron Legal  
41 News, Inc., to provide publication of notices of Sheriff sales and other necessary legal notices,  
42 with funds being collected up front by the Clerk of Courts, for the period 1/1/14 through  
43 12/31/18, with two five-year renewal options, is hereby confirmed and the County Executive is  
44 authorized to execute such contract.
