7 **A Resolution amending Resolution No. 2013-411 and confirming an award by the Board of**
8 **Control of a purchase contract with AT&T for a three-year term for dial tone, long**
9 **distance service and bandwidth increase for telephone/internet access, as Best Practical**
10 **Source, approved by the IT Board 5/28/13, in Council Districts 1, 2, 3, 4 and 8, in an**
11 **amount not to exceed \$44,730.00 per year for Department of Environmental Services**
12 **operations, for the Executive's Department of Environmental Services, and declaring an**
13 **emergency.**

15 WHEREAS, this Council previously adopted Resolution No. 2013-411, which confirmed
16 an award by the Board of Control of a purchase order with AT&T for the first year of a three-
17 year contract for dial tone, long distance service and monthly internet access, as Best Practical
18 Source, approved by the IT Board 5/28/13, in Council Districts 1, 2, 3, 4 and 8, in a total amount
19 not to exceed \$44,730.00 for all three years, for Department of Environmental Services
20 operations; and

22 WHEREAS, Resolution No. 2013-411 stated the term was for one year and the correct
23 term is three years, and stated the total amount was \$44,730.00 for all three years and the correct
24 amount is \$44,730.00 per year; and

26 WHEREAS, the Board of Control, at its meeting held October 30, 2013, rescinded
27 Directive No. 228-13 and awarded a purchase contract with AT&T for a three-year term for dial
28 tone, long distance service and bandwidth increase for telephone/internet access, in the amount
29 of \$44,730.00 per year, as Best Practical Source, approved by the IT Board 5/28/13, in Council
30 Districts 1, 2, 3, 4 and 8, for Department of Environmental Services operations, subject to
31 confirmation by County Council; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that the purchase contract is necessary and in the best interest of the County of Summit;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

41 Resolution No. 2013-411 is hereby amended to confirm an award by the Board of
42 Control of a purchase contract with AT&T for a three-year term for dial tone, long distance
43 service and bandwidth increase for telephone/internet access, as Best Practical Source, approved
44 by the IT Board 5/28/13, in Council Districts, 1, 2, 3, 4 and 8, in an amount not to exceed
45 \$44,730.00 per year, for Department of Environmental Services operations, is hereby confirmed
46 and the County Executive is hereby authorized to execute such purchase contract.
