7 **A Resolution awarding a purchase contract, subject to approval of the IT Board and the**  
8 **Board of Control, with SoundCom Systems for materials and labor for courtroom**  
9 **technology upgrades, under State Term Pricing, in an amount not to exceed \$166,842.00,**  
10 **for the Court of Common Pleas General Division, and declaring an emergency.**

12 WHEREAS, the Court of Common Pleas General Division desires to enter into a  
13 purchase contract with SoundCom Systems for materials and labor for courtroom technology  
14 upgrades, under State Term Pricing, in an amount not to exceed \$166,842.00; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
17 that it is necessary and in the best interest of the County of Summit to award a purchase contract,  
18 subject to the approval of the IT Board and the Board of Control, with SoundCom Systems for  
19 materials and labor for courtroom technology upgrades, under State Term Pricing;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

24 SECTION 1

26 Subject to confirmation by the IT Board and the Board of Control, a purchase contract is  
27 hereby awarded to SoundCom Systems for materials and labor for courtroom technology  
28 upgrades, under State Term Pricing, in an amount not to exceed \$166,842.00, and the County  
29 Executive is hereby authorized to execute such purchase contract.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to immediately  
35 provide for materials and labor for the courtroom technology project in 2013.

37 SECTION 3

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,  
48 were in meetings open to the public, in compliance with all legal requirements, including Section  
49 121.22 of the Ohio Revised Code.
