7 **A Resolution authorizing the County Executive to execute a temporary easement to the**
8 **City of Green on Parcel No. 2809041, located at 4950 Lauby Road in the City of Green, for**
9 **the purposes of allowing Green to grade and reconstruct Greensburg and Lauby Roads in**
10 **the City of Green, in Council District 8, for the Executive's Department of Environmental**
11 **Services, and declaring an emergency.**

13 WHEREAS, the County owns and operates Pump Station No. 88 on Parcel No. 2809041,
14 located at 4950 Lauby Road in the City of Green ("Pump Station Property"), in Council District
15 8; and

16
17 WHEREAS, Green plans to reconstruct the intersection of Greensburg and Lauby Roads
18 to build a roundabout ("Project"); and

19
20 WHEREAS, Green requires a temporary easement on three sections of the Pump Station
21 Property for a period of two years in order to build the Project and will compensate the County
22 \$500.00 for said easement pursuant to Ohio Department of Transportation guidelines; and

24 WHEREAS, a copy of the proposed temporary easement is attached as Exhibit A hereto
25 and is on file in the Office of the Clerk of Council and at the County Executive's Department of
26 Environmental Services State Road office; and

28 WHEREAS, the Executive's Department of Environmental Services has determined that
29 granting the temporary easement on the Pump Station Property would not interfere with the
30 operations of Pump Station No. 88; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that authorizing the County Executive to execute the temporary easement to Green on the Pump
34 Station Property is in the best interest of the County of Summit;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that:

39 SECTION 1

41 The County Executive is hereby authorized to execute a temporary easement
42 substantially in the form as set forth in the temporary easement attached hereto as Exhibit A to
43 the City of Green ("Green"), for the amount of \$500.00, for a period of two years, on the
44 County's Pump Station No. 88 property, Parcel No. 2809041, located at 4950 Lauby Road
45 ("Pump Station Property"), in the City of Green, in Council District 8.

47 SECTION 2

49 This Resolution is hereby declared an emergency in the interest of the health, safety and
50 welfare of the citizens of the County of Summit, and for the further reason that it immediately
51 authorizes the execution of a temporary easement to allow Green to construct a roundabout at the
52 intersection of Greensburg and Lauby Roads, in Council District 8.

16 121.22 of the Ohio Revised Code.


