7 **A Resolution confirming an award by the Board of Control of a renewal (third of five) of a**
8 **professional service contract with Norman R. Johnson, M.D., aka Advanced Correctional**
9 **Healthcare, Inc., for jail inmate medical services, for the period 1/1/14 to 12/31/14, in a total**
10 **amount not to exceed \$1,905,718.40, for the Sheriff, and declaring an emergency.**

12 WHEREAS, County Council previously adopted Resolution No. 2010-380, which
13 confirmed an award by the Board of Control of a professional service contract with Norman R.
14 Johnson, M.D., aka Advanced Correctional Healthcare, Inc., for jail inmate medical services, for
15 the period 1/1/11 to 12/31/11, with five options to renew for a one-year period, in a total amount
16 not to exceed \$2,043,598.28; and

18 WHEREAS, the Board of Control, at its meeting held December 4, 2013, awarded a
19 renewal (third of five) of the aforementioned professional service contract with Norman R.
20 Johnson, M.D., aka Advanced Correctional Healthcare, Inc., for the period 1/1/14 to 12/31/14, in
21 a total amount not to exceed \$1,905,718.40, subject to confirmation by County Council; and

23 WHEREAS, County Council has determined by reviewing all pertinent information that
24 the renewal of the aforementioned professional service contract with Norman R. Johnson, M.D.,
25 aka Advanced Correctional Care, Inc., is necessary and in the best interest of the County of
26 Summit;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

33 The award by the Board of Control of a renewal (third of five) of a professional service
34 contract with Norman R. Johnson, M.D., aka Advanced Correctional Healthcare, Inc., for jail
35 inmate medical services, for the period 1/1/14 to 12/31/14, in a total amount not to exceed
36 \$1,905,718.40, is hereby confirmed and the County Executive is hereby authorized to execute
37 such contract renewal.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the citizens of the County of Summit, and for the further reason to immediately
43 provide jail inmate medical services effective 1/1/14.

48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take


