A Resolution ratifying the County Executive's execution of a one-year policing contract with the Summit County Combined General Health District to provide one Sheriff's Deputy and one vehicle for community based policing, on a per unit basis, for Adult Protective Services, for the period 10/1/13 through 9/30/14, for which the District will pay the County the amount of \$135,000.00, and authorizing the Executive to execute an addendum to the policing contract to add an additional Sheriff's Deputy and vehicle during the term, for which the District will pay the County the additional amount of \$72,591.54, for a total amount of \$207,591.54, for the Sheriff, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2013-123, which authorized the County Executive to execute a one-year policing contract with the Summit County Combined General Health District to provide one Sheriff's Deputy for community based policing, on a per unit basis, related to an Adult Protective Services Pilot Project, for the period 10/1/12 through 9/30/13, with one option to renew for an additional one-year term, for a total amount of \$90,000.00; and

WHEREAS, this Council subsequently adopted Resolution No. 2013-337, which authorized the Executive to execute an amendment to the aforementioned policing contract to add one additional Sheriff's Deputy for a period of 10 weeks, for the period 7/22/13 through 9/20/13, for an additional cost of \$20,000.00, for a new total amount of \$110,000.00; and

WHEREAS, the Executive executed a new one-year policing contract with the Summit County Combined General Health District to provide one Sheriff's Deputy and one vehicle for community based policing, on a per unit basis, for Adult Protective Services, for the period 10/1/13 through 9/30/14, in the amount of \$135,000.00; and

WHEREAS, it is necessary for this Council to ratify the Executive's execution of the aforementioned policing contract; and

WHEREAS, the District has requested to add an additional Sheriff's Deputy and vehicle during the term, in an additional amount of \$72,591.54, for a total amount of \$207,591.54; and

WHEREAS, it is necessary to authorize the Executive to execute an addendum to the aforementioned policing contract to add the additional Sheriff's Deputy and vehicle; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to ratify the Executive's execution of the aforementioned one-year policing contract with the Summit County Combined General Health District and to authorize the Executive to execute an addendum to the policing contract to add the additional Sheriff's Deputy and vehicle, for the total amount of \$207,591.54;

SECTION 1

The County Executive's execution of a one-year policing contract with the Summit County Combined General Health District to provide one Sheriff's Deputy and one vehicle for community based policing, on a per unit basis, for Adult Protective Services, for the period 10/1/13 through 9/30/14, in an amount of \$135,000.00, is hereby ratified.
