WHEREAS, YES Program had unexpended WIA funds, in the amount of \$134,651.79, at the end of calendar year 2013, which must be appropriated and expended by 6/30/14; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to appropriate the aforementioned carryover WIA funds, in the amount of \$134,651.79;
