7 **A Resolution confirming an award by the Board of Control of a purchase order with**  
8 **METRO Regional Transit Authority for 31-day and 1-day bus passes for work-mandated**  
9 **clients and Summer Youth Employment participants, for the period 1/1/14 through**  
10 **12/31/14, as Best Practical Source, in an amount not to exceed \$318,000.00, for the**  
11 **Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held January 22, 2014, awarded a  
14 purchase order with METRO Regional Transit Authority for 31-day and 1-day bus passes for  
15 work-mandated clients and Summer Youth Employment participants, for the period 1/1/14  
16 through 12/31/14, as Best Practical Source, subject to confirmation by County Council; and,

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the purchase order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

26 The award by the Board of Control of a purchase order with METRO Regional Transit  
27 Authority for 31-day and 1-day bus passes for work-mandated clients and Summer Youth  
28 Employment participants, for the period 1/1/14 through 12/31/14, as Best Practical Source, in an  
29 amount not to exceed \$318,000.00, is hereby confirmed and the County Executive is hereby  
30 authorized to execute such purchase order.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide bus passes for work-mandated clients and Summer Youth Employment participants for  
37 the period beginning 1/1/14.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take  
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
43 effect and be in force at the earliest time provided by law.

48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
