7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with the County of Summit Clerk of Courts for IV-D provider contract services to**  
9 **reimburse the Clerk of Courts for filing services and expenses directly related to Child**  
10 **Support Enforcement Agency-initiated child support filings, for the period 1/1/14 through**  
11 **12/31/14, in an amount not to exceed \$141,984.35, for the Prosecutor – Child Support**  
12 **Enforcement Agency, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held March 5, 2014, awarded a  
15 professional service contract with the County of Summit Clerk of Courts for IV-D provider  
16 contract services to reimburse the Clerk of Courts for filing services and expenses directly  
17 related to Child Support Enforcement Agency-initiated child support filings, for the period  
18 1/1/14 through 12/31/14, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that the contract is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
24 of Ohio, that:

28 The award by the Board of Control of a professional service contract with the County of  
29 Summit Clerk of Courts for IV-D provider contract services to reimburse the Clerk of Courts for  
30 filing services and expenses directly related to Child Support Enforcement Agency-initiated  
31 child support filings, for the period 1/1/14 through 12/31/14, in an amount not to exceed  
32 \$141,984.35, is hereby confirmed and the County Executive is hereby authorized to execute such  
33 contract.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and  
38 welfare of the citizens of the County of Summit, and for the further reason to immediately  
39 provide for the reimbursement of filing services and expenses in 2014.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.



10 121.22 of the Ohio Revised Code.


