WHEREAS, until recently, the Ohio Department of Transportation ("ODOT") would evaluate the condition of all state, interstate and local highways that form the network of roadways eligible for federal transportation funding; and			
WHEREAS, the Akron Metropolitan Area Transportation Study ("AMATS") would utilize the scores to assist in ranking the various highway sections to determine which highways in the AMATS region would receive federal funding for resurfacing or reconstruction projects; and			
WHEREAS, ODOT has informed AMATS that ODOT will cease its evaluation and scoring of all local highways across the state: and			
WHEREAS, AMATS has elected to continue with the pavement evaluations using a private firm to field verify the pavement conditions, document the field conditions with measurements and photographs, enter the findings into a database and provide software and training to assist in determining proposed roadway improvement projects for the highways within the AMATS area; and			
WHEREAS, the funding for this endeavor will be provided partially from the federal transportation funds allocated by ODOT to AMATS and partially from the local governmental agencies participating in the program; and			
WHEREAS, a single collaborative contract with the vendor providing a unified comparable evaluation of the highway network will assist in the distribution of federal highway funds; and			
WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit that the County Executive be authorized to execute any documents necessary to enter into the aforementioned collaborative
